9. Non-teaching staff


Term: The term of the Antiragging Committee shall be three years.

Meetings: The Anti-ragging Committee shall meet at least monthly once for first three months of academic year.

Functions of the Committee:

- During the first three months of an academic year, submit a monthly report on the status of compliance with Anti-Ragging measures
- Establish, fund and operate a toll free anti ragging helpline which could be accessed by students in distress.
- Any distress message received at the Anti-Ragging helpline or complaint shall be simultaneously relayed to the head of the Institution, Warden of hostel and Nodal officer of affiliating University.
- The head of institution shall be obliged to act immediately in response to the complaint.
- The telephone numbers of the Anti-Ragging helpline and all the important functionaries in the Institute, Head of the Institute Faculty members, Members of the Anti-Ragging committee and Anti Ragging Squad, Warden of hostel and other authorities shall be widely disseminated for access or to seek help in emergencies.
- The committee should maintain appropriate data base to be created out of affidavits affirmed by students and parents and stored electronically by the institution and such database shall also function as a record of ragging complaints received and the status of the action taken thereon.
- The committee shall make available the database to a non-government agency to build confidence among the public
