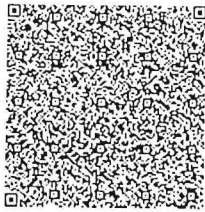

1. Purpose of this Memorandum

This MoU is intended to recognize the general basis for a cooperative and collaborative working relationship between the two parties.

The objective of the proposed relationship is to enable CHEMIN C&I PVT. LTD. to support Sri Manakula Vinayagar Engineering College in the following areas:

- ❖ Students Implant Training, Project Internship, Industrial Visits and Project works etc.,

Each party, by mutual consent, may involve in the cooperative and collaborative actions, any of its controlled affiliates competent in the concerned action.

2. Nature of memorandum

Through this MoU, CHEMIN C&I Pvt. Ltd. and SMVEC intend to develop a special relationship, whereby effective Industrial support, to the extent possible from time to time, is provided to Sri Manakula Vinayagar Engineering College.

3. Responsibilities

3.1 CHEMIN C & I Pvt. Ltd. and SMVEC shall be responsible for the conduct of their assigned responsibilities. Neither CHEMIN C&I Pvt. Ltd. nor SMVEC shall be responsible to the other parties for any losses that they may suffer arising out of the understanding.

The parties shall be responsible for insuring their respective premises, equipment and personnel for any claims that may arise from the conduct of the understanding.

3.1 CHEMIN C & I Pvt. Ltd. agrees to entertain the students and faculty members to CHEMIN C&I Pvt. Ltd. for industrial visits. CHEMIN C & I Pvt. Ltd. will not collect any fees from the visitors from SMVEC for the visits. 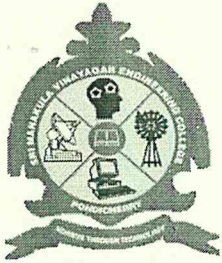

3.2 Following are the monetary terms for the implant, project & seminar:

- Industrial Visit - Shall be provided at Free of Cost (4 Industrial Visit / year).
- Final Year Intern project certificate shall be provided for the technical support they have provided to the organization at Free of Cost (up to 5 Students per year). Stipend will not be provided.
- Guest Lecture shall be provided for two batches a year with prior intimation before a month, this shall not be charged.
- For Customized Weekend Seminars & Training for trainer's session 15-30% discount from the fixed price will be applicable for SMVEC students and Faculties.
- CHEMIN C & I - Institute of Instrumentation Management Certification training without placement to the interested students shall be provided with discount @ 15-30%. (Discount is not applicable for Training cum Placement Batch)

3.3 Students deputed for the training courses as mentioned in Para above will ensure that the security of CHEMIN C&I Pvt. Ltd. is not hampered.

3.4 Industrial visit is only for one day. Students who visit the training will be given first hand information about various types of services and equipment available in CHEMIN C&I Pvt. Ltd.

3.5 Chemin C&I Pvt. Ltd. shall not bear any expenditure for the above industrial visits/implant training courses.

3.6 Students deputed by the SMVEC for the implant training shall not claim any right for appointment in CHEMIN C&I Pvt. Ltd.

3.7 SMVEC agrees to avail all the services from CHEMIN C&I Pvt. Ltd. during the period of their MOU.

4. Status of MoU

This MoU is intended to record mutual understandings of the parties hereto, as of the date hereof.

This MoU would be subject to the laws (and such rules & regulations) of India as may be applicable during the tenure of this MoU.

To discharge the responsibilities of each party, and/or when specific obligations or financial commitments appear necessary to the parties, the parties by mutual consent shall enter directly (or through the concerned affiliate), into specific agreement(s) defining in detail the respective obligations and commitments of each party, and in particular the program of work and the financial conditions of its execution.

5. Validity

The MoU will be valid for one year from the date of signing. The parties shall meet to decide a possible renewal of this MoU three months before its termination. A specific addendum shall then be signed by the parties.

6. Amendment

The MoU may be amended upon the mutual consent of all parties; but such amendment shall have no impact on any specific agreement then in force.

7. Termination

This MoU may be terminated by any party upon providing a written notice of three months. It shall also terminate automatically upon the bankruptcy of any of the Parties or in the event of force majeure prohibiting its continuity.

8. Arbitration

This MoU shall be subject to exclusive jurisdiction of courts in which the location of SMVEC, where there is a presence of Chemin C&I Pvt. Ltd. Office. The parties in the dispute will share equally the cost of arbitration as intimated by the arbitrator.

9. Confidentiality

All parties acknowledge the confidentiality of the information, which may be transferred between the parties from time to time as being essential to this MoU and agree not to disclose the same to any third party. However, each party shall be free to disclose such information as is part of the public domain at the time of disclosure, or required to be disclosed by official authorities in accordance with the applicable law.

The obligations of all the parties as defined above shall apply notwithstanding termination of this MoU.
