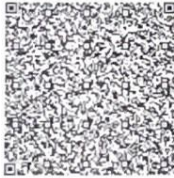

**MEMORANDUM OF UNDERSTANDING**

**(MoU)**

On Academic Co-operation

between

**SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE**

Madugarai Road, Madagadipet, Mannadipet Commune  
Puducherry – 605107, India.

And

**MURUGAN MILLS**

SKS Nagar , Kurinjipadi - 607302  
Tamil Nadu, India.

A) The Parties

**Sri Manakula Vinayagar Engineering College, Puducherry**(hereinafter "SMVEC") and **MURUGAN Mills** wishes to conclude this Memorandum of Understanding (hereinafter: "MoU") to facilitate the development of collaborations in the disciplines of Academic Support, Students and Faculty Training, Internships, Placement support, Outreach activities and in other possible ways of knowledge sharing.

B) The Objective

1. The objective of this cooperation is to train the students as per industry needs and faculty members in their respective research domain.

C) Areas of Collaboration

2. SMVEC and Murugan Mills agree to explore the possibility of engaging in the following areas of collaboration:
  - a. Academic Support
  - b. Students and Faculty Training
  - c. Lab Infrastructure Development
  - d. Consultancy Projects
  - e. Internships
  - f. Placement Support
  - g. Outreach activities
3. The development and implementation of specific activities based on this MoU will be further negotiated and agreed between both parties as applicable depending on the specific project. Each party agrees to carry out these activities in accordance with the rules and regulations of the respective countries and institutions.
4. It is understood that the implementation of any of the types of co-operation stated in Clause 2 shall depend upon the availability of resources and financial support of the parties concerned.

5. Coordination

SMVEC and Murugan Mills shall name a coordinating committee consisting of teaching/research staff and (a) Principal, SMVEC or his/her nominee, (b) Director, Murugan Mills, or his/her nominee, (c) Coordinator from SMVEC (d) Coordinator from Murugan Mills will periodically review and identify ways to strengthen cooperation between the two organizations.

D) Term and Termination

6. This MoU will take effect from the date it is signed by representatives of the two parties. It will remain valid for a period of two years, and may be continued thereafter after suitable review and agreement.

7. This MoU may, at any time during its period of validity, be terminated by one of the parties upon prior notice to the other in writing not later than six months before the termination date. Once terminated, neither SMVEC nor Murugan Mills will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, SMVEC and Murugan Mills will ensure that all activities in progress are allowed to complete successfully.

E) General

8. This MoU may only be amended or modified by a written agreement signed by the representatives of each party.

9. The parties may disclose certain confidential information to the other in relation to any future proposal made under this MoU. Nondisclosure agreements will be made for each such event between the individuals involved from both institution and industry.

a. Should there be a dispute relating to any aspect of academic cooperation the Principal of SMVEC and Director of Murugan Mills or his/her nominee will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

b. This MoU is signed subject to approval by respective academic/administrative bodies.
