AMENDEMENT NO. 1 ("Amendment-1") TO MEMORANDUM OF UNDERSTANDING dated 6th  
November 2020 (the "MOU")

Amendment - 1 Effective Date: 1<sup>st</sup> August 2022

BETWEEN: **Sri Manakula Vinayagar Engineering College**  
Having its principal office at Mannadipet Commune, Madagadipet, Puducherry  
605107 (hereinafter referred to as "Institute")

HAND ON THE ONE

AND **Tata Consultancy Services Limited,**  
Having its corporate office at TCS House, Raveline Street,  
21 D S Marg, Fort, Mumbai 400001, India  
(hereinafter referred to as 'TCS')

ON THE OTHER HAND

TCS and Institute shall be jointly referred to as "Parties" and individually as "Party" and shall mean and include their respective successors-in-interest and permitted assigns in this Amendment-1.

**WHEREAS:**

1. The Parties entered into the MOU effective dated 1<sup>st</sup> June 2020 for a period of five years ending 31<sup>st</sup> May 2025 w.r.t TCS' Academic Interface Program aimed towards developing and designing and/or providing industry specific application-oriented courses; and
2. The Parties would mutually like to amend certain terms of the MOU including extending the term of the MOU and are now recording their understanding as set forth herein.

**NOW, THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:**

1. The Parties agree that the MOU is hereby extended for a further period of two (2) years, i.e. till 31<sup>st</sup> May 2027 ("Extension Term-1") whereby Option 2 [TCS Designated Curriculum – Offered for full time four year undergraduate engineering program (B.E./B.Tech.))] will be offered to the batches joining in the academic year A.Y2022 (ending A.Y 2026) and A.Y 2023 (ending A.Y 2027).
2. In the MOU, the following **paragraph one of clause II (B)** (Role of Institute) mentioned viz:

***Pre-amended paragraph:***

Institute shall ensure that it holds all valid permissions, authorizations, approvals and consents, licenses and registrations, which may be required under the applicable laws, policies and procedures prevalent from time to time, for launch, administration and instruction of the TCS Designed Course(s) and Curriculum (agreed to in Annexure A or amendment thereof) and the same shall be kept valid and subsisting throughout the period of this MOU or till the completion of the TCS Designed Course(s) / Curriculum, whichever is later.

**Stands amended and replaced with the following provision:**

***Amended paragraph:***

Institute shall ensure that it holds all valid permissions, authorizations, approvals and consents, licenses and registrations, which may be required under the applicable laws, policies and procedures prevalent from time to time, for launch, administration and instruction of the TCS Designed Course(s) and Curriculum (agreed to in Annexure A or

amendment thereof) and the same shall be kept valid and subsisting throughout the period of this MOU or till the completion of the TCS Designed Course(s) / Curriculum, whichever is later. *Institute will run the course(s) as per the approvals received for the relevant course(s).*

3. In the MOU, the following **paragraph three of clause II (B)** (Role of Institute) mentioned viz:

**Pre-amended paragraph:**

Institute will ensure to provide equal status to the TCS Designed Course(s) / Curriculum (at par with all other courses) while offering it to students applying to the Institute. This will be done by placing the option of this course curriculum in all communication medium (College Website, Student Application forms, Brochures etc.) to ensure maximum students undertake the TCS Designed Course(s) / Curriculum.

**Stands amended and replaced with the following provision:**

**Amended paragraph:**

Institute will ensure to provide equal status to the TCS Designed Course(s) / Curriculum (at par with all other courses) while offering it to students applying to the Institute. This will be done by placing the option of this course curriculum in all communication medium (College Website, Student Application forms, Brochures etc.) to ensure maximum students undertake the TCS Designed Course(s) / Curriculum. *Institute shall ensure that the procedure related to admission to relevant course(s) will be in line with the rules & regulations of relevant bodies governing the general admission and will be adhering to the guidelines set by them.*

4. In the MOU, the following **paragraph two of clause III** (Other Terms and Conditions) mentioned viz:

**Pre-amended paragraph:**

Upon mutual agreement, TCS and Institute may at any time enter into a specific definitive agreement(s) (hereinafter referred as "Definitive Agreement(s)") setting out therein the mutually agreed detailed terms and conditions applicable to the various courses to be provided by TCS under such Definitive Agreement(s).

**Stands deleted.**

5. Other than as set forth herein, all other terms and conditions of the MOU shall remain unaltered, subsisting and binding on the Parties and continue to remain in full force and effect for the Extension Term-1.

6. The Amendment-1 shall be treated and deemed as part of the MOU for all intents and purposes.
