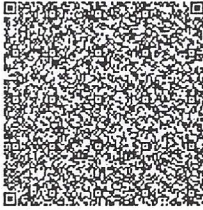

3. The Organization will offer career guidance, aptitude training sessions, internship opportunities and industrial visits (1 per year) to the students at the Department / College, providing insights into industry trends, career paths, and personal development strategies.
4. The College agrees to cooperate with the Party II in the selection of students for conducting various workshops and courses, and providing necessary logistical support.
5. Both parties agree to collaborate in organizing and facilitating any events, workshops, or activities outlined in this MOU.

This MOU shall remain in effect for a period of 5 Years, commencing on 29th January 2024 and terminating on 29th January 2029.

Responsibilities:

- The Organization will be responsible for the development and delivery of the workshops, courses, and training sessions as outlined in this MOU.
- The College / Department will assist in the selection of students, provide necessary facilities for online sessions, and support the promotional efforts.

Intellectual Property:

Any intellectual property developed or shared during the execution of this MOU shall be the joint property of both parties, and its usage shall be subject to mutual agreement.

Confidentiality:

Both parties agree to treat any confidential information shared during this collaboration with the utmost confidentiality and will not disclose such information to any third parties without prior written consent.

Any amendments or modifications to this MOU shall be made in writing and signed by authorized representatives of both parties.


Termination:
