

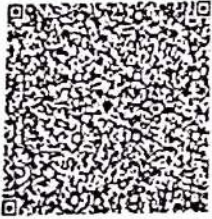

MEMORANDUM OF UNDERSTANDING (MoU)

CLAUSE 1

CO-OPERATION

CLAUSE 2
