ROLE AND RESPONSIBLE OF THE DYNAMIC NETWORKING INSTITUTE

- 1. The **Dynamic networking Institute** shall depute the required faculty for the courses offered for the training program.
- 2. All necessary courseware (Hardcopy and Softcopy of the materials) can be supplied to the students.
- 3. The theoretical and practical sections shall be handled by the deputed faculty from **Dynamic networking Institute**.
- 4. The final Graded / Participation / Course Certificate shall be issued to the students those undergone and passed the course conducted.
- 5. **Dynamic networking Institute** will provide campus Assistance (will provide campus offer for 12 members or will bring 2 core companies for campus recruitment at SMVEC)
- 6. Size of the batch is permitted maximum of 25 Students.
- 7. Number of Trainers/Batch of Students to be noted in MOU.
- Feedback at regular intervals will be considered and Corrective action will be taken accordingly.
- 9. Trainers Details, profile of trainers to be submitted along with Quotation

ROLE AND RESPONSIBLE OF THE SMVEC

- The INSTITUTION shall nominate a coordinator as a single point of contact (POC) in the college for the entire courses conducted by the **Dynamic networking Institute**.
- 2. The INSTITUTION shall provide the available infrastructure & basic facilities such as electricity, water, telephone, etc.; suitable for conducting the training courses.

VALIDITY OF MEMORANDUM OF UNDERSTANDING

This agreement will be in effect initially for a **period of three years** from the date of signing of this MoU by both the parties and will be renewed further if mutually agreed. Either party may terminate the agreement by written letter signed by the appropriate official of the Institution initiating the notice. Such notice must be received by the other party three months prior to the effective termination date. However, obligations and communications already contracted for and involving their parties shall be honoured and continued by both parties until such commitments are completed.
