This MoU is made for setting up Centre of excellence at Sri Manakula Vinayagar Engineering College for the purpose of providing top notch industry oriented global certification programs for the students of SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE.

In this connection, the following points are agreed upon:

1. Objective

The overall objective of TRAIN-LAB is to provide skill development, advanced technology hands-on training to enhance employment opportunities. To achieve this objective, will mobilize all the admitted students from Sri Manakula Vinayagar Engineering College in order to make them industry ready.

2. Recitals

- a. TRAIN-LAB is an organization providing technical skill training and Technology consultancy services in advanced technology areas to students, jobseekers and industry personnel.
- b. SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE is a conglomerate of institutions Affiliated to Pondicherry University, that offers Engineering and Management Degree Programs.
- c. The purpose of this agreement is with reference to defining the areas of cooperation, benefiting both SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE and Train-Lab Academy.

This agreement witnesses as follows:

3. **Scope of Agreement:**

Train-Lab Academy:

TRAIN-LAB to liaison with SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE for providing the following services to the students of Sri Manakula Vinayagar Engineering College:

1. Establishment of State of the Art Technology Infrastructure.
2. Global Certification training programs.
3. Research and Development activities at the campus.
4. Global Corporate affiliation and Certification.
5. Academic project support.
6. Placement support.
7. Joint research proposal support.
8. Faculty Development/Training Programs.
9. Industrial Tie-Up with Industries.

Train-Lab Academy will establish Industry Standard COE with following infrastructure:

- 420 Computer PCs divided among 14 Centres.
- Air-Conditioning, Projector and Digital Board will be provided to each class-room.
- Tables and chairs will be provided, equally divided among 14 Labs.
- The affiliation cost will be paid by Train-Lab Academy.
- The annual Renewal fee for all the Partner companies will be paid by Train-Lab on behalf of SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE.
- A dedicated Internet connection will be maintained and paid by Train-Lab for the COE.


In addition to the lab infrastructure mentioned above, Train-Lab will be investing in providing technology specific equipment's and software which are clearly mentioned in Annexure-1.

Train-Lab Academy will have full rights on the ownership of all the equipment's procured for the establishment of the Centre of Excellence until the completion of the MOU tenure of 5 years. All the equipment's and the infrastructure investments will completely belong to Sri Manakula Vinayagar Engineering College after successful completion of the tenure period of 5 years. However, The college hall full rights to use the facilities of the Centre of excellence and the faculties during the tenure of the MOU.

3. SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE:

To promote courses run by TRAIN-LAB ACADEMY, SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE will mobilize all the admitted students from the college.

4. Training Support & Methodology

- The training shall be conducted at SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE premises.
- The Subject matter experts will be provided by Train-Lab Academy for conducting the training for students as well as Faculty training.
- TRAIN-LAB shall provide all support needed for imparting the necessary training to the students mobilized by SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE.
- Each Training program of specified duration will be carried out on mutually agreed terms.
- TRAIN-LAB will issue the Certificates to the students from respective Companies wherever possible upon successful completion of the certification exam by the students.

5. Course fee and mode of payment:


- a. TRAIN-LAB ACADEMY shall prepare a consolidated list of students sponsored by SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE and enrolled to the different courses and make available a copy of the same to respective colleges at the beginning of each Academic Semester.
- b. It is Mutually agreed between Train-Lab Academy and Sri Manakula Vinayagar Engineering College that Sri Manakula Vinayagar Engineering College would sponsor all the admitted students from Semester 1 to Semester 8. However, For the Academic Year 2019-20, The final year students are not considered for training since the students have already completed their Placement activities.
- c. The program will be offered at 5,000/- INR for each student each semester irrespective of the program chosen/Offered. Each Academic year will comprise of 2 semesters. IT IS MANDATORY FOR STUDENTS TO CHOOSE ONE PROGRAM EACH SEMESTER.
- d. The payment to be classified into ten Equal installments. The first Installment of the program fees to be paid at the beginning of the academic year and the subsequent Installments to be paid every month for a total of 10 months until the end of the academic year.

2. SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE fully understands that the fees charged is a fair estimate of the expenditure incurred by TRAIN-LAB ACADEMY for utilizing the infrastructure, designing & developing the program content, acquiring the necessary principal licenses, hardware, providing the course material and for

arranging lectures by certified experts in the current technologies including assistance in extending placement assistance to eligible students trained by Train-Lab Academy.

Note: All payments shall be made in favor of TRAIN-LAB ACADEMY.

Any program offered to any student outside Sri Manakula Vinayagar Engineering College will be charged 6,000/- INR for the academic year 2019-20. Sri Manakula Vinayagar Engineering College is obliged to make a payment of 4,500/- INR to Train-Lab Academy and keep the rest 1,500/- INR per student as infrastructure fees.

The program fees for outside students to be revised every academic year depending upon students and faculty feedback.

5. General Agreements

- Both the parties can issue press release, make public announcement, or other such disclosure related to this Agreement without the other party's prior consent as long as it does not affect the aim, objective, ethical values and reputation of the respective organizations.
- Train-Lab Academy will have full ownership of all the equipment's and infrastructure established as a part of Centre of excellence until the end of the validity of this MOU i.e. June 2024. After successful completion of the tenure of the MOU, Sri Manakula Vinayagar Engineering College will have full ownership of the equipment's irrespective of the future collaborations. However, During the tenure of the MOU, Sri Manakula Vinayagar Engineering college is free to use the facilities of the Centre of Excellence as well as make use of the expertise of the Subject matter experts deployed at the COE.

6. Course Deliverables:

TRAIN-LAB will follow its standard methodologies related to conduct, student attendance, globally accepted quality norms, student feedback, internal assessments, examination, evaluation and certification, smooth & effective delivery of course content and competence building of the trainee student. The training will take place at Sri Manakula Vinayagar Engineering College. The minimum & maximum student batch size for commencing a batch will be decided on mutually agreed numbers and it is as per the available seating capacity at Sri Manakula Vinayagar Engineering College.

The listed courses can vary from time to time and courses shall be added / deleted based on mutual convenience, in discussion by both the parties.


Validity:

Arbitration Clause.

Should there be a dispute relating to any aspect of academic cooperation, Managing Director, Train-Lab and Director, Sri Manakula Vinayagar Engineering College will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

If amicable settlement is not reached between the parties then such unresolved dispute or difference of opinion concerning or arising from the MoU and its implementation, breach or termination whatsoever, including any difference or dispute as to the interpretation of any of the terms of the MoU, shall be referred to the arbitrator or a sole arbitrator appointed to GMDC and AML. The Arbitrator shall give reasoned award. Then arbitration shall be governed by arbitration and Conciliation Act, 1996 (India) and conducted in the city of Puducherry. The language of arbitration shall be English. The parties shall share the cost of arbitration equally.
