DRUG ABUSE MONITORING POLICY OF SRI MANAKULA VINAYAGAR ENGINEERING COLLEGE, PUDUCHERRY

Drug abuse is a global phenomenon, which affects an individual, family and society. The addiction to drugs spoil the career of students and staff members leading to increase in crime and violence. Awareness programmes on drug abuse on a regular basis are conducted to prevent these kind of problems.

OBJECTIVE OF THE POLICY

The main objectives of the policy are as follows:

- To motivate the Staff and students to fight against drug abuse
- To hold regular awareness programme for students and staffs in order to educate them on the ill-effects of drugs
- To advocate for the welfare of those suffering from drug abuse
- To effectively strengthen vigilance in supply reduction through Police and Customs Department keeping in mind the topographical location of our institution and its close proximity to the Madagadipet area
- To address drug abuse policy in a broader sense

COMPOSITION OF COMMITTEE

As per the guidelines of Government, the Institution has constituted Drug Abuse Monitoring Committee with Head of the Institution as Ex Officio Chairman. The committee includes, Administrative Officer, Deputy warden Hostel, NSS Coordinator, Police persons from Local police Station, Physical Director, Physician and senior professors.
