

Minutes of Meeting Anti-Ragging Committee

Date: 07.09.2023 **Time:** 10.30 AM

Venue: AV Hall

- The meeting commenced with a welcome address by member secretary by extending a
 warm welcome to all new members for academic year 2023-2024, and outlined the
 importance and significance of the anti-raging committee in the institution.
- 2. It was decided to update the existing WhatsApp group including the new committee members to share information related to Anti-Ragging and other related information.
- 3. The member secretary requested all the newly inducted committee members to understand the roles and responsibility of an ideal Anti-Ragging committee.
- The team discussed the importance of identifying blind spots within the campus to ensure student safety of the 1st year students. Areas such as stairwells, isolated corridors, and corners were highlighted.
 - (i) The proposals for installing additional CCTV cameras and increasing patrolling in these areas were considered. A task force was formed to identify and report blind spots within a week.
 - (ii) The anti-ragging squad members are instructed to conduct a survey of the campus to identify blind spots, and prepare a report with recommendations for monitoring and submit it by month end.
 - (iii) The committee discussed the preparation and distribution of a circular addressing anti-ragging measures. The content of the circular was reviewed, emphasizing zero tolerance for ragging and the legal consequences.
- It was agreed that the circular would be distributed electronically to all students and displayed on notice boards. The anti-ragging committee will to finalize and release the circular by month end.
- 6. Strategies were discussed for monitoring student activities during break hours to prevent incidents of ragging. Suggestions included deploying faculty members and security personnel at key boarding points like bus boarding points. A roster for monitoring during break hours was proposed and will be implemented starting from next week.
- 7. The importance of creating awareness about a ragging-free campus was highlighted. Various awareness campaigns, including posters, and orientation sessions by the

committee members, were proposed. An awareness campaign schedule was agreed upon, starting with an orientation session for new students.

- 8. The need for enhanced monitoring of hostels and college bus boarding points was discussed to ensure student safety, particularly during early mornings and late evenings. It was decided to increase the presence of wardens and security personnel in these areas.
- 9. The member secretary thanked all the members for their kind cooperation and based on the report received so far, there is no case of ragging reported till now. The efforts taken by anti-ragging committee members are appreciated by everyone. The next meeting is scheduled on 04.10.2023.

- 8. Proposal for additional workshops focused on conflict resolution and peer support.




- 1. The meeting was called to order by Dr.S.Sundararaman, who welcomed attendees and acknowledged the progress made so far.


