Minutes of Meeting

Anti-Ragging Committee

Date: 05.09.2024

Time: 12.30 PM

Venue: Central Library

1. The meeting began with a welcome address by Dr.S.Sundararaman, highlighting the critical importance of maintaining a ragging-free campus and ensuring a safe environment for all students.
2. A brief overview of the current anti-ragging laws and institutional policies was provided. Emphasis was placed on strict adherence to the guidelines set by UGC and other regulatory bodies.
3. Staff members assigned for campus monitoring, particularly in hostels, canteens, and isolated locations are requested to carry out physical inspection during break hours. A duty roster was proposed, assigning teachers to patrol during peak hours. An awareness session planned during induction programme for student orientation.
4. It was decided to appoint senior students as a mentor was suggested by members for first-year students to promote a friendly environment.
5. Posters and flyers about the consequences of ragging placed in strategic locations around campus are ensured by members of committee.
 - i. Installation of additional CCTV cameras in areas lacking coverage was approved.
 - ii. Anti-ragging squads, consisting of staff and senior students, will be formed to regularly monitor key areas.
 - iii. A complaint boxes will be set up, and an online form for reporting incidents need to be again highlighting students for future registration.
6. The protocol for handling reported incidents was reiterated. Any report will lead to an immediate inquiry, followed by necessary disciplinary actions in line with institutional policy. A support system for victims of ragging was discussed, with counseling services being made readily available.
7. It was recommended that the staff maintain a visible presence in common areas to deter any inappropriate behavior. The meeting concluded with a reminder of the seriousness of the issue and a call for collective effort.
8. The Chairperson thanked all the members for their kind cooperation and based on the report received so far, there is no case of ragging reported till now. The efforts taken by



Minutes of Meeting Anti-Ragging Committee

Date: 04.10.2024

Time: 10.30 AM

Venue: Central Library

1. The meeting commenced with a welcome address by member secretary and the minutes of previous meeting held on 05/09/2024 were discussed and the action taken for the following points are highlighted in the meeting.
 - (i) The proposals for installing additional CCTV cameras and increasing patrolling in these areas were considered. A task force was formed to identify and report blind spots within a week.
 - (ii) The anti-ragging squad members are instructed to conduct a survey of the campus to identify blind spots, and prepare a report with recommendations for monitoring and submit it by month end.
 - (iii) The committee discussed the preparation and distribution of a circular addressing anti-ragging measures. The content of the circular was reviewed, emphasizing zero tolerance for ragging and the legal consequences.
2. It was agreed that the circular would be distributed electronically to all students and displayed on notice boards. The anti-ragging committee will to finalize and release the circular by month end.
3. Strategies were discussed for monitoring student activities during break hours to prevent incidents of ragging. Suggestions included deploying faculty members and security personnel at key boarding points like bus boarding points. A roster for monitoring during break hours was proposed and will be implemented starting from next week.
4. The importance of creating awareness about a ragging-free campus was highlighted. Various awareness campaigns, including posters, and orientation sessions by the committee members, were proposed. An awareness campaign schedule was agreed upon, starting with an orientation session for new students.
5. The need for enhanced monitoring of hostels and college bus boarding points was discussed to ensure student safety, particularly during early mornings and late evenings. It was decided to increase the presence of wardens and security personnel in these areas.
6. The member secretary thanked all the members for their kind cooperation and based on the report received so far, there is no case of ragging reported till now. The efforts taken





1. Member Secretary welcomed new members for the academic year 2024-2025 and emphasized the significance of the anti-ragging committee.
2. Decision made to update the existing WhatsApp group with new committee members for sharing anti-ragging information.
3. Newly inducted members were encouraged to understand the roles and responsibilities of the anti-ragging committee.
4. Discussion on identifying blind spots on campus for first-year student safety. Areas highlighted included stairwells, isolated corridors, and corners.
5. Proposal to install additional CCTV cameras and increase patrols was made. A task force was formed to identify blind spots within a week. Anti-ragging squad members were instructed to survey the campus for blind spots and submit a report with recommendations by month-end.
6. Reviewed and prepared circular addressing anti-ragging measures, emphasizing zero tolerance and legal consequences. The circular will be distributed electronically and posted on notice boards by month-end.
7. Strategies for monitoring activities during break hours were discussed, including deploying faculty and security personnel at key locations. Implementation of a monitoring roster is set to start next week.
8. The importance of creating awareness about a ragging-free campus was highlighted. Proposed campaigns and orientation sessions for new students were discussed. An awareness campaign schedule was agreed upon.


